Privacy and Use Statement

This Privacy and Use Statement applies to data collected by the Kentucky Golf Association (KGA) through this web site and services; it does not apply to data collected through other sites that may be linked to this Site or other sources. Other sites and services linked to or from this Site are governed by their own privacy statements, which should be viewed before proceeding.

The KGA is committed to protecting the security of the personal information you provide. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure.

The KGA may disclose personally identifiable information in response to legal process, for example, in response to a court order or a subpoena. We also may disclose such information in response to a law enforcement agency's request, or where we believe it is necessary to investigate, prevent, or take action regarding illegal activities, suspected fraud, situations involving potential threats to the physical safety of any person, violations of our terms of use, to verify or enforce compliance with the policies governing our sites and applicable laws or as otherwise required or permitted by law or consistent with legal requirements. All data, including personally identifiable information, however, belongs to the KGA. While the KGA does not generally disclose such data, it may disclose some information (but not credit card information, for example) for its business purposes.

Our agents and contractors who have access to personally identifiable information are required to protect this information in a manner that is consistent with this privacy statement and are not authorized to use the information for any purpose other than to carry out the services they are performing by, for, or in conjunction with the KGA.

Although we take appropriate measures to safeguard against unauthorized disclosures of information, we cannot assure you that personally identifiable information that we collect will never be disclosed in a manner that is inconsistent with this privacy statement.

In some cases, the KGA may collect non-personal information. Examples of this type of information include the type of Internet browser you are using, the type of computer operating system application software and peripherals you are using and the domain name of the web site from which you linked to our website. We use your information on an aggregated basis to do such things as operate and enhance our website.

The KGA may update or change this privacy policy at any time and such changes will become effective immediately unless otherwise stated. This Privacy Policy page will state the date it was last updated and we invite you to review this page whenever you use this Site.

Terms & Conditions

KGA EClub Memberships

The person(s) completing the registration represent they are purchasing an KGA EClub Membership for the purpose of becoming a member of the Kentucky Golf Association.

I/we confirm I am/we are familiar with the rules to join the KGA EClub as listed below:

1. Membership is valid for one year (365 days) from the date of purchase
2. Bona fide resident of the Commonwealth of Kentucky
3. Payment is required with each membership application
4. Adhere to the [Rules of Handicapping](#)
5. Agree that the KGA may occasionally send marketing communications about programs, services and offers from allied groups
6. Authorize the KGA to use social media functions such as e-mail, X (formerly Twitter), Facebook, LinkedIn or Instagram to deliver personal messages at my choosing whether a member or not

Auto-Renewal Policy

Your AGA and club membership term may be renewed for an additional twelve (12) month period (“**Renewal Term**”) by paying the then-current membership fees prior to the expiration of your current membership term. By agreeing to renew your membership, you authorize the Kentucky Golf Association to charge the then-current membership fees (inclusive of taxes, service fees and processing fees) to the credit card on file associated with your account. The Kentucky Golf Association reserves the right to change the annual membership fee rates for any Renewal Term. Any changes to membership fees will be communicated in advance in an annual email notification.

You may have the option to enroll in auto-renew in order to renew your AGA and club membership. **If you enroll in auto-renew, then unless you cancel your membership or your participation in auto-renew before the cancellation deadline, the credit card on file with your account will automatically be processed on or near your anniversary billing date each year and you will be charged the then-current membership fees (inclusive of taxes, service fees and processing fees) for the following 12-month Renewal Term.** Members will receive an annual reminder email in advance of when the membership fees payment will be processed, informing them of the amount of the membership fees for the upcoming Renewal Term. **Members may cancel their participation in auto-renew and avoid incurring the annual charges by opting out online through the GHIN app or GHIN website, or contacting the Kentucky Golf Association by sending notice of cancellation via email to**

kentucky@kygolf.org. However, to avoid incurring the fee for the following renewal period, cancellation must take place before the cancellation deadline; that is, no later than five (5) business days before the scheduled membership fees processing date as disclosed in the renewal notice. Following cancellation, members will continue to have access to their membership benefits through the end of the current membership term if that year has been paid in full. If at any time during the membership term the member's eligibility changes, auto-renew will be de-activated and re-enrollment will be required. Auto-renew will begin upon the start of the first Renewal Term and processed annually on or about the anniversary of your AGA and club membership activation date.

Members will receive an annual email receipt after payment is processed for any Renewal Term. It is your responsibility to ensure that your credit card is on file and all information is up to date. If the Kentucky Golf Association is unable to process payment through your credit card on file, your membership may be suspended or cancelled, and you may be refused member benefits until payment is complete. Failure to renew your membership prior to expiration of the current membership term may result in cancellation of your membership, which may include inactivation of your scoring record, Handicap Index and associated data.
