Practice Round

There is not an official practice. The course regular fees apply.

Lodging

There are several hotels in the area with a variety of rates. To find what best suite your needs, visit richmondchamber.com/Lodging.

Registration

There is no formal registration. Please report to the starting tee at least 5 minutes prior to your assigned starting time. At the starting tee you will be provided the Notice to Competitors, Hole Location sheet, Pace of Play Policy and any daily information. There is no call to the tee; it is the player's responsibility to arrive on time.

Food & Beverage:

The club will have food and beverage services available. Cash or credit cards are acceptable forms of payment. **Outside food and beverages are not allowed at the facility.**

General Information:

The Rules of the United States Golf Association govern play. This information sheet, the Kentucky Golf Rules Hard Card and any site-specific Local Rules and Conditions of Competition sheets are supplements to the Rules of Golf. Local Rules of the host course do not apply. The KGA Tournament Committee, who are charged with conducting this championship, shall settle all questions. Reference to the Rules and Appendix I may be found in the 2012-16 Rules of Golf book. Unless otherwise noted the penalty for breach of a Local Rule or Condition is: **2 Strokes.**

Format:

36 Holes of Four-Ball Stroke Play. The lower score of the partners is the score for the hole. If one partner fails to complete the play of a hole there is no penalty. Note: Rule 31-3 requires the gross score of whichever partner's scores is to count be individually identifiable; otherwise the side is disqualified.

Pace of Play Guidelines and Procedures:

Rule 6-7 states in part, players must play without delay and in accordance with any pace of play guidelines the Committee may establish and thereafter prescribes penalties for slow play. A time par will be established for this competition and it is the players responsibility to stay in position. If a group become out of position, it will be subject to timming and possible penalty.

Distance Measuring Devices:

Distance Measuring Devices are allowed for its championships.

Player Carts:

Golf carts are permitted and included in the entry fee. A maximum of two carts per group are allowed.

Caddies:

Caddies are permitted, however you are responsible for making your own arrangements for a caddie.

Practice Range:

The practice range opens one hour before the first starting time, weather permitting. Range balls will be set up at the practice range and are complimentary for competitors only before the stipulated round or a play-off

Play-off:

In the event of a tie for the qualifying place or the alternate positions, the players concerned shall compete in a hole-by-hole play-off. The starting hole and time shall be announced at the scoreboard immediately after the Committee has verified the results of the qualifier.

Withdrawals:

Please withdraw via the online registration system or contact the KGA. If you need to withdraw any time after 5:00 on June 28, please call (502) 779-0986 and leave a message on the voicemail.

Attire & Conduct:

Proper golf attire is required. Blue jeans, designer jeans, tee shirts and tank tops are prohibited. Shorts must be mid-thigh. Golf shirts with a traditional or mock collar are required. The host facility is a "spikeless facility."

Close of Competition:

The championship shall be deemed to have closed when all scores have been returned and the committee has announced the results.
