# Guidelines

**Guidelines for Selection of**  
**Members of Kentucky Golf Hall of Fame**

- I. a. The committee to choose the entrants to the Kentucky Golf Hall of Fame shall consist of the following:**
- KGA-PGA, Inc. President  
KGA President  
Kentucky Section PGA President  
3 Representatives from the Kentucky Golf Association (appointed by the KGA President)  
3 Representatives from the Kentucky Section PGA (appointed by KPGA President)
- b. The KGA-PGA, Inc. President shall chair the committee.**
- c. KGA-PGA, Inc., KGA, and KPGA Presidents shall serve on this committee in concurrence with their terms of office. The KGA and KPGA appointees will serve terms of six years, and the terms shall be staggered to enable appointment of a new KGA and KPGA representative to the committee for a six-year term every two years. The respective KGA or KPGA President shall make any appointment necessary to complete the unexpired terms due to resignation, etc. In the event a member of the committee is nominated as a candidate for the Kentucky Golf Hall of Fame, the committee member may elect to have their name removed from consideration as a candidate, or, excuse themselves from the committee during the period in which they remain a candidate. The respective KGA or KPGA President shall appoint a replacement to serve on the committee for the duration of the period in which the committee member remains a candidate.**
- d. The committee shall be provided with a list of the nominees at least fourteen days before the annual selection meeting. Prior to the preferential ballot at the selection meeting committee members will have the opportunity to reject a nominee. If two or more members by secret ballot vote to reject the same candidate he or she shall be removed from consideration.**
- e. Voting on the selection shall be by preferential ballot. The committee shall vote on all nominations using a 3, 2, 1 preference. In this process each member shall give his or her first choice a 3, second choice a 2, and third choice a 1. The six nominees with the highest total vote will then be voted on using the same process. To be inducted the nominee must receive two thirds of the maximum available vote. This figure shall be determined by multiplying the attendance by 3. Should all members of the committee be in attendance the maximum available vote would be 27. Under these conditions a nominee must receive 18 votes to be selected. Should only eight members be in attendance the available vote would be 24 and a nominee would have to receive 16 votes for election. This numerical requirement may be waived by a majority vote of the committee at the selection meeting.**

**II. The Committee shall consider the following guidelines when electing individuals to the Kentucky Golf Hall of Fame:**

- a. Kentucky resident for at least five years
- b. Playing achievements
- c. Contribution to and promotion of the game
- d. Golf course architecture
- e. Turf research and turf management
- f. National recognition
- g. Teaching of the game
- h. Contribution to junior golf
- i. Personal integrity

**III. A schedule shall be complied with as follows:**

- a. The officers responsible must have necessary committee appointments completed by April 1. Ballots must be mailed to all board members, member clubs, media and interested parties by May 30. The committee must make their selection by August 31.
- b. The awards ceremony shall be held in the fall of each year at a location to be determined by the KGA-PGA, Inc.

**IV. Duties of the KGA-PGA, Inc. staff will include:**

- a. Assure that the timetable for appointments, balloting and selection is followed.
- b. Make public the results of the voting.
- c. Coordinate the purchase of the awards and the banquet presentation.
- d. Make every effort to receive statewide publicity during the nomination period and following the selection.

### Kentucky Golf Hall of Fame Voting

Prior to the preferential ballot at the selection meeting, committee members will have the opportunity to reject a nominee. If two or more members by secret ballot vote to reject the same candidate, he or she shall be removed from consideration.

Voting on the selection shall be by preferential ballot. The committee shall vote on all nominations using a 3, 2, 1 preference. In this process each member shall give his or her first choice a 3, second choice a 2, and third choice a 1. The six nominees with the highest total vote will then be voted on using the same process.

To be inducted the nominee must receive two thirds of the maximum available vote. This figure shall be determined by multiplying the attendance by 3.


