Dear Committee Members:

First let me express my sincere appreciation to the committee for inducting me into the Kentucky Golf Hall of Fame in 2016. I received many awards during my 35 years of service to the Federal Aviation Administration and I am proud of my service to the aviation industry. However, all the pride I take in the acknowledgements I received from the Federal Aviation Administration cannot compare to the pride I felt the night I was inducted into the Kentucky Golf Hall of Fame. That was an experience I will never forget and I am so grateful for the honor you bestowed upon me. I am writing this letter hoping you will bestow that same honor to a person I believe has truly earned his rightful place in the Kentucky Golf Hall of Fame, Don Smith.

I first met Don at Danville Country Club in 1989. As I recall, Don was a participant in the Kentucky Amateur that year but failed to make the cut for the final round. The committee was short on staff and Don was asked if he would serve as a starter for the final round. I believe Don was a bit reluctant to take on the role but he agreed and did a marvelous job. Prior to that day, Don was more of a player than a golf administrator but this one assignment started him on a path that resulted in him being the starter at numerous Kentucky golf events over the next 25 years.

I know the committee has already received letters in support of Don's nomination so I will not offer any redundant information except to say he has been a true ambassador for Kentucky golf for many years. His service to the KGA, the KGA Seniors, and his administrative labors with the various boards, with which he has served, have all been well documented. My intent is to not repeat those accomplishments; rather it is to try to give you a bit more insight into the man himself.

Don has served on the KGA, KPGA, SKGA boards and also served for several years as a member of the Hall of Fame Committee. As such he has had to make many difficult decisions that impacted not only himself, but others as well. When making decisions it is a natural instinct to make the decision that is normally in your own best interest but many times our own personal best interest is not what we need to protect. It takes a special and dedicated person to put their personal feelings aside and support the common good rather than their own personal best interest. Don Smith is such a person.

Today the KGA and KPGA have what I believe to be the best personal relationship ever!!! We are now starting our third year of our three (3) year MOU which basically established a financial plan that helped to insure the future of KGA-PGA. This MOU is a product of cooperative teamwork between the KGA and KPGA leadership and I am proud to have been a part of the committee who worked to finalize this arrangement. In 2014 the KGA and KPGA representatives knew the financial issues facing the KGA-

PGA and worked in unison to establish a financial plan for the future. We managed to put our personal differences aside and work for the common good of the KGA-PGA. This was not always the case.

Several years ago, the KGA-PGA was in a state of flux. There were internal debates concerning finances, staffing, and it was hard for both sides to come to a mutual agreement. One of the issues was the KGA had 4 representatives on the board while the KPGA only had 3. This imbalance of power was a concern to the KPGA. The KPGA wanted to be equal partners, but the KGA was reluctant to relinquish the balance of power. Dave Nicholas and Mark Hill have already mentioned this in their nominating letters and Mike Thomas has also alluded to Don's role in this matter. So once again I do not want to bore you with more details about the specifics of his action, rather I want to focus on the personal impact this situation had on Don. Don knew the right thing to do was to balance the power but in order to do that he had to cast his personal feeling aside and separate himself from his peers and support the KPGA leadership. Although this was the right thing to do, it caused Don some personal pain because some felt he should have supported the KGA and not the KPGA. Don accepted the criticism directed at him and held steadfast to his beliefs this was the right thing to do. History has proven it was the right thing to do but it came at a great personal sacrifice to Don Smith.

You may have heard of the chaos theory, AKA the "butterfly effect". Loosely translated this theory stipulates that small causes/events may create larger consequences/effects. Applying that theory to our current issue, today we have a thriving, KGA-PGA mainly because of what one individual had the courage to do more than 15 years ago.

Think about it. Without Don and his action, you may not be here today debating his induction. There probably would not be a Hall of Fame, A Golf House, a KGA-PGA, a MOU or any other such entities/agreements we now take for granted.

He has given many years of service to Kentucky Golf in many different ways. His accomplishment as a player, his service to the KGA, his service to amateur golf, his service to the KPGA are all a part of what makes Don a man to be revered. He has tackled many tough issues and has had success and failures along the way. There are many reasons why Don should be inducted, but his one selfless act of standing tall and doing the right thing at the right time with unselfish resolve has in my mind earned him a rightful place in the Kentucky Golf Hall of Fame.

I know how difficult your job is as I too have served on the HOF committee in the past. No doubt you will be reviewing several worthy candidates and I appreciate all the diligent work each of you must do to reach your conclusions. Yours is a thankless job but a most needed one none the less. I am proud of the work you do and I am proud to submit this letter in support of Don Smith.

Dear Committee Members:

Having been on the Kentucky Golf Association Board for over twenty-five years now, I have developed an opinion of what kinds of skills and talents a nominee for the Kentucky Golf Hall of Fame should possess in order to be inducted into that prestigious group. Certainly those talented golfers who have worked hard on honing their skills and have excelled at playing the game should be members.

A second, and equally important group of folks are those who have made it possible for the talented players to demonstrate and improve their playing skills for the world to see. Those persons who give unselfishly of their time, talent, and resources to organize tournament events, to teach, to attend meetings of organizations governing the tournaments, to learn and administer the rules of golf, and to create opportunities for the talented and the not so talented to enjoy playing this great game of golf. Without tournament opportunities, how would the talented golfer showcase his or her talents? Without governing organizations, who would be able to conduct high level golf opportunities? Without many hours of work behind the scenes by giving, caring, and dedicated individuals, who would organize the programs of the governing bodies?

I also believe that whenever possible, a person who is worthy of induction into the Kentucky Golf Hall of Fame should be inducted during his or her lifetime so that person may be properly recognized for his or her accomplishments.

I am pleased to nominate Don Smith as an outstanding individual for consideration by the committee for induction into the Kentucky Golf Hall of Fame. Don Smith is a person who has served Kentucky Golf for many years in an unselfish and honorable manner.

In the fall of 1986 Don entered the Kentucky Senior Amateur at Summit Hills Country Club. At a dinner between rounds of the 36-hole event it was announced that plans were under way to form a Kentucky Senior Golf Association. John Owens, Fred Allen and Tom Musselman who were heading the effort asked for volunteers to serve on the initial board of directors. Don asked and was accepted and attended the first board meeting later that fall at Big Spring Country Club.

Don attended his first Kentucky Golf Association board meeting in 1989 as one of the two KSGA members selected to serve on that board. He continued in that position until becoming an emeritus member in 2011. He became the president of the KGA in 1993 and president of the KGA-PGA, Inc. in

1994. Prior to and following that he was president of the KSGA in 1992 and 1996. He was a KSGA board member from its founding in 1986 until the merger with the KGA in 2013. He was appointed to the USGA Senior Amateur Championship Committee in 1996 until retiring in 2007. As a member of that committee he was a rules official for two NCAA division I championships and 8 USGA Senior Amateur Championships.

Don was very active in the KSGA and participated in a majority of their events plus several Kentucky Opens and Kentucky Amateur championships. He qualified for the 1989 Kentucky Amateur at Danville Country Club but did not make the 36 hole cut. He volunteered to be a starter for the remainder of the tournament and this piqued his interest in the rules of golf and tournament administration. This would lead to attending 10 USGA/PGA Rules of Golf Seminars over the next several years. He was also the starter for the Ben Hogan tour in the two years the tournament was played in Elizabethtown. It was his first contact with professional rules officials and increased his interest in this part of the game.

In 1994 Don was presented with the J.W. Janes award by the Kentucky Golf Association in recognition of his contributions to amateur golf in Kentucky. In 2002, he was the recipient of the first President's Award from the Kentucky Section of the PGA of America.

Don and Fred Allen formed the Kentucky Senior Golf Foundation with the intention of making contributions to worthy charities through their 501-3c classification. The board of directors of the foundation made many contributions to charitable organizations such as the Ronald MacDonald House. Due to the great interest in junior golf the purpose and mission of the foundation was changed to providing assistance to junior golfers from Kentucky who had qualified for either the boys or girls USGA amateur championships. Since that change over forty worthy juniors have received up to \$1000 to assist them in the expenses necessary to compete on a national level.

Don got his start in the game of golf when his family moved to Anchorage, KY in 1941 and became members of Owl Creek Country Club. Shortly thereafter he was introduced to two gentlemen who became his mentors as he developed as a player and took a great interest in the sport. At age 13 he began caddying for Judge John Marshal, Jr. and his protégé, Harry (Buddy) Moorhead.

Judge Marshal was a multiple winner of the Kentucky State Amateur Championship, one of the founders of the Kentucky Golf Association, a member of the Kentucky Golf Hall of Fame, and a great student of the golf swing. His protégé, Buddy Moorhead, had won the Kentucky State High School Golf Championship and was recovering from tuberculosis at that time and one of the better amateur players in the state. They devoted a great deal of time in explaining the finer points of the game and the challenges of life to Don. Don caddied for Buddy in most of his major competitions against the better amateurs, Benny Owen, George Helm, Omer Doll, and Johnny Owens and experienced the feeling of good competitive golf. One of the highlights of his caddying career was to caddy for Buddy Moorhead in an exhibition match at the old Valley View Golf Club in New Albany. The foursome was made up of the host professional, Jimmy Scott, the Indiana Amateur Champion, Fred Wampler, Buddy Moorhead, the Kentucky Amateur Champion and Byron Nelson who was at the peak of his game at that time.

During his high school years, Don participated in the Kentucky State High School Championship for three years finishing as high as fifth as a senior in 1949. At that time in the spring of 1949 John Owens, who was captain of the University of Kentucky golf team, was developing a combination athletic/academic scholarship along with the coach at the university, Frank Atkins, the golf professional at Lexington's Picadome Golf Club. They were aware that Don had won the Jefferson county high school championship and after playing a round at Owl Creek with Don offered him the new scholarship. This scholarship was for one year and was for the huge amount of \$60 for each semester!

In the spring of 1950 he was a member of a freshman golf team, this was during the period that you could not participate on the varsity level until your sophomore year. They played a limited schedule against Transylvania, Centre and suffered a humiliating defeat by Lafayette High School with Gay Brewer, Jr. and John Y. Brown, Jr. who would later become team mates at UK.

At this time, John Owens had just won the SEC individual championship, the only Kentucky player to this day, and was advised by Bernie Shively, the athletic director that they were going to drop golf since it was a non-revenue sport. John begged and pleaded and Mr. Shively agreed to keep golf if John would be the coach. He did and that lasted for some seven years! This did provide some interesting circumstances since John was Don's big brother in Phi Delta Theta fraternity and also his golf coach.

For the next three years, Don played on the varsity golf team. Virtually all of the competition was at match play with the exception of the SEC Championship which was a stroke play event. He was able to compete against and with a number of excellent players who continued on to have fine careers as players and teachers such as Mike Souchak, Jim Flick, and Tommy Veach to mention a few. In his senior year, 1953, the UK golf team was made up of Gay Brewer, Jr., Ches Riddle, John Y. Brown, Jr. and Don Smith and had a very respectable record with Brewer nearly winning the SEC individual at Athens Georgia Country Club.

After his graduation from UK in 1953, Don entered the United States Air Force for three years serving the last two as a navigator on KC-97 tankers for air refueling. His last year in service was spent at Little Rock Air Force Base, Arkansas. This was a very new base and the commanding officer, Brig. Gen. Joe Preston, wanted a golf course on the base. So for the last two months or so of his time Don laid out the design for the course using aerial photographs, there was a reconnaissance wing on the base, and saw the initial construction before his separation from the Air Force. It is still in use today.

Don has been a member of Harmony Landing CC, now merged with Big Spring CC, since 1969. He served over 10 years as a member of the board of directors the majority of that time as greens chairman. Still an active player as long as the tees are short enough he has made 6 aces, three of them on the same hole at Harmony Landing.

Based on the premise that persons who have made an outstanding contribution to the organization and administration of tournament golf in this state should be members of the Kentucky Golf Hall of Fame, I believe that you will agree that Don Smith deserves a place in the Hall of Fame. He has certainly earned it. It is my hope that I have done an adequate job of representing how truly qualified this individual is. Please allow his record, his time, his hard work, and this accomplishments speak for themselves. If so, I

believe that you will see this man as thoroughly qualified for entry into the Kentucky Golf Hall of Fame. Please also consider other items that I have attached that further validate and accent the credentials of Don Smith.

Dear Members of the Kentucky Golf Hall of Fame Selection Committee:

It was my great pleasure to nominate Mr. Don Smith as a candidate to become a member of the Kentucky Golf Hall of Fame. This is the third year for consideration of Mr. Smith by the committee. You have selected three outstanding individuals for membership into the HOF in the last two years. I am respectfully requesting your continued review and consideration of Don Smith as a potential member of the HOF.

I know that you will carefully review the information that has previously been submitted regarding Don, so I will not bore you with a reiteration of those many accomplishments. However, it occurred to me most recently that I had omitted one of Don's greatest accomplishments regarding the betterment of golf here in Kentucky.

Many of you probably do not know that Don was the person who initiated the effort to provide parity for the Kentucky Section of the PGA on the KGA-PGA board. The KGA-PGA board was formed in 1979 by a group of forward thinking professionals and amateurs to administer the golf programs of both the Kentucky Golf Association and the Kentucky Section of the PGA. That board is currently made up of four members from the KGA and four members from the KPGA. What many people do not know or remember is that the 4 to 4 membership ratio was not how that board was originally created. It was created as a seven member board consisting of 4 KGA members and 3 KPGA members. I do not know why it was done that way since I did not become a member of the KGA board until 1987. I did serve on the KGA-PGA board twice in conjunction with being a KGA officer in both the early and late 1990's.

During the early 2000's, the members of the KPGA began to express their desire to change the composition of that board to achieve the parity that we have today, four members from each organization. The KPGA members approached Don, who was a member of the KGA-PGA board at the time, with the idea and asked if he could support that idea and if so, could he convince the KGA board to go along. Like the idea of the Kentucky Senior Golf Association, Don saw the merit in granting parity to the KPGA. He saw it as an opportunity to cause the organizations to grow closer and to work together in an even greater way than we had before. Many of the members of the KGA board were skeptical about doing this and were not in favor of the KGA giving up its majority on the board. Don was able to convince a majority of the KGA board to go along with his idea.

I am now serving my third stint on the KGA-PGA board and the first since the parity issue was resolved. I can tell you from first-hand experience that the KGA-PGA board is functioning at a far higher level with equal representation than it was when the amateurs held the majority. The KPGA has stepped up in a big way to provide additional funding to the organization that provides such great services to the professionals and amateurs of this state. I am proud to serve with the KPGA members of that board because they saw the need for additional funding, worked through the process of educating their members, and negotiated with us in good faith to reach an agreement that should keep the KGA-PGA financially secure and stable well into the future.


My point to you is that Don Smith had the vision to see that parity would provide the ability for our boards to work more cooperatively well before I did or many of my colleagues on the KGA board. I am

grateful that he had the courage, leadership, and vision to see this opportunity and act on it in a positive way.

I feel that I would be remiss if I had not made you aware of this accomplishment that should rightfully be credited directly to Don Smith. Would it have happened without Don's leadership? No one knows. But I do know that he is the one that made this important change happen.

The materials that you have received previously from me and others complete the resume of a man that I believe deserves to be in the Kentucky Golf Hall of Fame. Again I ask for your thoughtful consideration for this worthy individual.

Please accept this letter of recommendation for Don Smith, as you consider him for entry into the Kentucky Golf Hall of Fame.

Membership in the Hall of Fame should bring with it, a strong criteria for entry. The criteria should include someone who has given back to the game of golf, and someone who contributed to make the game better for those involved. Don Smith fits into this category, as someone who has served Kentucky Golf for many years. Don has served in various capacities involving tournament administration and rules, as a volunteer. NOMINATION OF DON E. SMITH TO THE KENTUCKY GOLF HALL OF FAME

It is my pleasure to nominate Don E. Smith, a native of Kentucky, to be inducted into the Kentucky Golf Hall of Fame. Don E. Smith is eminently qualified and deserving of this honor. For several years, I had the privilege of working closely with Don for the Kentucky Senior Golf Association. (Henceforth the KSGA). During those years, I observed the great leadership team of Fred Allen and Don E. Smith as they guided the KSGA through its development into the wonderfully successful organization it is today. Through my first-hand observations, discussions and other input, I will attempt to submit a knowledgeable biography of Don E. Smith for your consideration.

As did many of aging golfers, Don started his golfing experiences as a caddy. His caddy experience was unique because he became the caddy for none other than John Marshall, Jr. As we know, John Marshall, Jr. became the first inductee into the Kentucky Golf Hall of Fame. Also, Judge Marshall, as he was called, became the first President of the Kentucky Golf Association. The Judge was a mentor to Don E. Smith in helping him learn the game of golf. He must have helped Don develop well because Don eventually got a golf scholarship at the University of Kentucky. When Don played for UK, it was a pretty good team as a couple of his teammates were Johnny Owens and Gay Brewer. Don has enjoyed golf as a low handicap player for many years. He has won several Sr. Club Championships at Harmony Landing. However, playing golf with some of the best only laid the groundwork for his many big contributions to golf in Kentucky.

In 1986, at the Ky. Sr. Amateur Championship held at Summit Hills, Don E. Smith became a member of the Board of Directors of the newly formed KSGA. He has continued to serve on this Board to present day. Fred Allen was President until 1991. Don became his Vice-President and served in that capacity 1989 until he became President of KSGA in 1992. In 1993, Don became President of the Kentucky Golf Association. Don was elected President of the KGA-PGA in 1994. It is a matter of record that Don E. Smith performed very well in each of these positions. Through his leadership, these organizations became more and more involved in supporting the development of Junior Golf throughout the state of Kentucky. This trend of full support of the KGA, PGA and KSGA for Junior Golf has continued until we now have a JUNIOR GOLF PROGRAM of which we have reason to be proud. In my observations, Don has always been an important person in the development of our JUNIOR GOLF PROGRAM.

It is known, if the committee is for the betterment of golf in Kentucky, Don E. Smith will be willing to devote and find time to serve. Don takes special pride of the fact that he chaired the committees at his Club when they found their outstanding Golf Professional, Mike Thomas and their outstanding Greens Superintendent, Jay Charnes. As Chair of the Greens committee for his club, Don was involved in a number of modifications of the course to make it a more contemporary layout.

Don E. Smith is a person of integrity. He believes in doing things right and following the rules to a tee. He has been actively interested in the rules of golf for many years. He attended his first USGA-PGA rules of golf workshop at Hilton Head Island in 1991 and completed his seventh workshop in 2002. In 1996 Don started serving on the USGA Senior Championship Committee

I appreciate your help in identifying a replacement and you are correct that we will be making those appointments later this year or early in 2008.

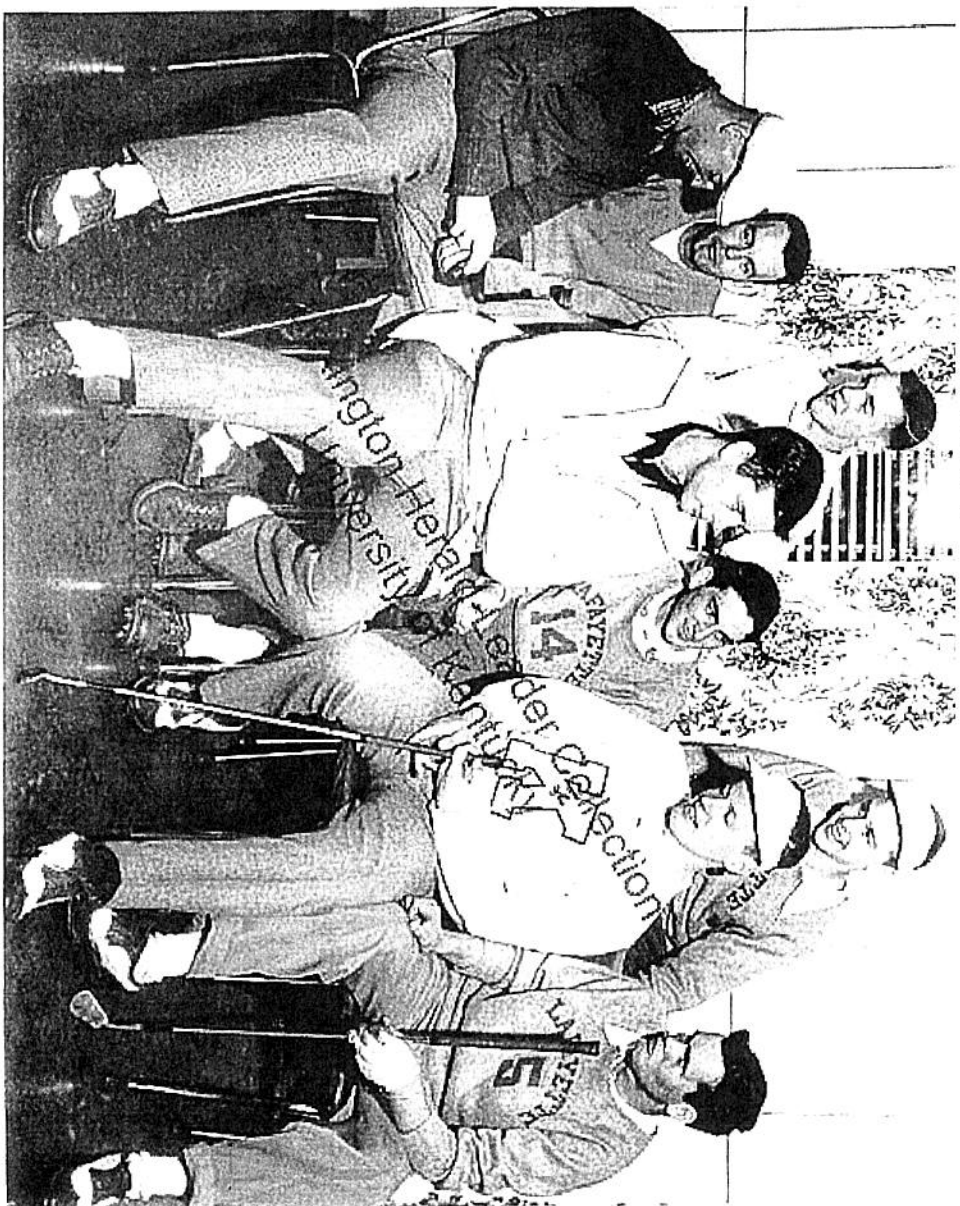
We will miss you in Kansas in September but look forward to another wonderful championship at an outstanding venue.

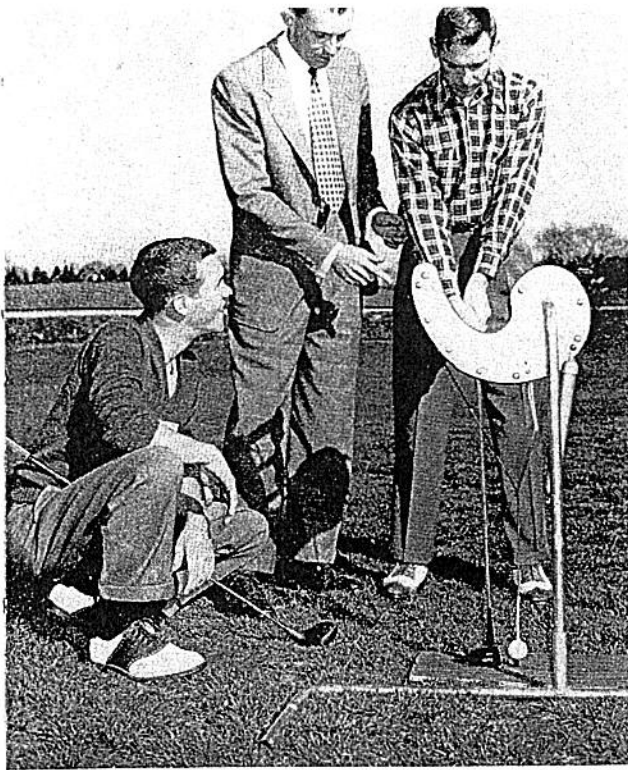

After a brilliant start, the 1952 Wildcat golfers cooled off and ended the season with a record of seven wins, six losses, and two ties.

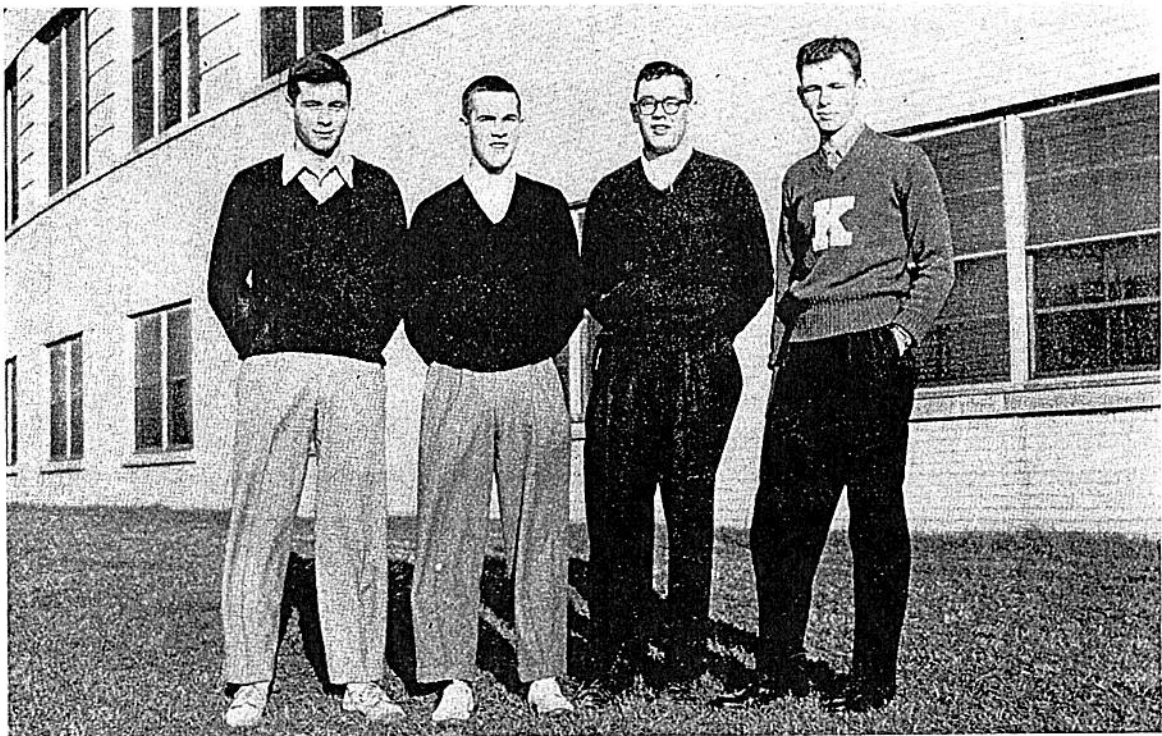
